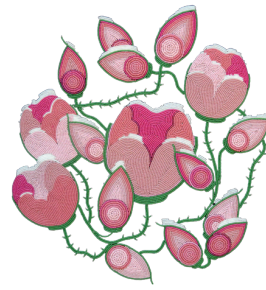

YEAR IN REVIEW



PARTNERSHIPS WITH MMF DEPARTMENTS /AFFILIATES AND REGIONS

The Métis CFS Authority has been meeting with various MMF Departments, Affiliates and Regions to prepare for the prevention ask under *An Act respecting First Nations, Inuit and Métis children, youth and families*. This work has evolved into some great immediate partnerships and collaborations.

MÉTIS JUSTICE INSTITUTE (MJI)

The Métis CFS Authority and agencies have partnered with MJI to have a Justice Worker work with the youth and families of the Métis CFS system to navigate the court system. This worker will also be able to assist workers who may not be familiar with the court system and what MJI can offer our youth and families through their department. The ability to use other MJI services for our families such as mediation and diversion will be a great resource to utilize that is culturally-appropriate and Métis specific.

MEDO AND ED SIMARD GENERAL STORE

Métis Child and Family Services has partnered with MEDO to support a winter clothing drive through the Ed Simard General Store. All donations of winter clothing went to families supported through our CFS agencies. Winter items such as socks, toques and mitts, winter boots, men's jackets, infants and children's jackets were dropped off at the ESGS at 150 Henry or 205 Eaton Avenue in Selkirk, MB and delivered to our Child and Family Services agencies for distribution to our families.

NORTHWEST METIS COUNCIL - GENDER BASED VIOLENCE TRAINING

The Métis Authority, Michif CFS Agency and Northwest Metis Council staff developed a partnership where Gender Based Violence Training will be delivered throughout the regions as well as co-facilitating information sessions to the Locals.

MÉTIS AUTHORITY TRAINING

The Métis CFS Authority has created a Red River Métis Governance training. This training is mandatory for all staff, boards and foster parents. The Authority Board of Directors, both agencies' Boards of Directors, and Executive Management from the Authority and agencies have been trained along with numerous staff. Louis Riel Institute's General Manager has joined our Authority trainer to co-facilitate sessions. LRI also partners with our agency to deliver our Cultural Training.

LOUIS RIEL CAPITAL CORPORATION (LRCC), ECONOMIC DEVELOPMENT AND HOUSING

The Métis CFS Authority has been partnering with LRCC and Economic Development on developing standardized leases, assisting with our capital needs for the Federal Ask and are actively looking for buildings to meet Métis Child and Family Services system's future needs.

MÉTIS CFS LAWS

Work on the Red River Métis Child and Family Services Laws continues. Updates to reflect the language in the Treaty, the potential for services outside of Manitoba and the recent changes to the Manitoba CFS Laws are being made. The language within the Laws is also being updated to match the language changes happening in the field.

CENTRAL REGISTRY OFFICE

The Métis CFS Authority and the agencies have been working directly with the Central Registry Office (CRO) in obtaining Citizenship for our children, youth, families and staff. CRO has been working with our Citizenship Liaison Officers (CLO) at the Authority and both agencies to navigate the registration process. The Central Registry Office has a designated staff person in their office to train and be a point of contact for the CLOs.

MMF POLICY UNIT

The Métis CFS Authority works closely with MMF's Senior Policy Unit on *The Act respecting First Nations, Inuit and Métis children, youth and families* initiatives. As Indigenous Governing Bodies give notice, the Métis Authority has been asked to monitor all Section 12 Notifications received by our Métis Government.

YEAR IN REVIEW



MMF ANNUAL GENERAL ASSEMBLY

The Métis CFS Authority was the Sector Lead for the MMF's Annual General Assembly Registration and General Information. The Métis CFS Authority staff were responsible for these two areas. This included ordering and gathering all of the items for the Volunteer Appreciation bags and printing and organizing all of the lanyards for general registration and staff registration.

The MCFCS and MCFS agencies' staff assisted in the Elders' Lounge throughout the AGA as well as organizing and assisting the Elders for the evening of entertainment.

COORDINATION AND FINANCIAL AGREEMENTS RELATED TO THE FEDERAL ACT

Discussions continue towards finalizing a coordination and funding agreement between the Métis, federal and provincial governments for child and family services. These meetings continue to take place regularly.

We remain hopeful that both a funding agreement and a coordination agreement will be completed in the near future.

STRATEGIC PLANNING SESSIONS

In January 2023, the Minister Responsible for Métis Child and Family Services, MMF's Senior Policy Analyst, Métis CFS Authority Board of Directors and the Executive Management from the Authority attended a Strategic Planning Session where the Priorities in the Minister's mandate letter were reviewed and a plan was developed to ensure these Priorities are delivered on.

In February 2023, the Board of Directors for the Authorities and agencies along with their Executive Management teams, met to build on the Strategic Plan developed in January 2023 at the Authority Strategic Planning Session.

AGREEMENTS WITH YOUNG ADULTS

An Agreement with Young Adults (AYA) for support services is offered to youth who are under a permanent order at the time they turn 18 years of age and whose further planning meets the criteria below. These agreements maybe renewed up until the age of 21 years. The reasons for an agreement include:

- Educational Goals
- Transition to Adult Services
- Transition to Independent Living
- Employment Training
- Treatment Programs
- Other services that will provide an opportunity for the young adult to achieve safety, success, and better outcomes, while being supported through culturally appropriate services

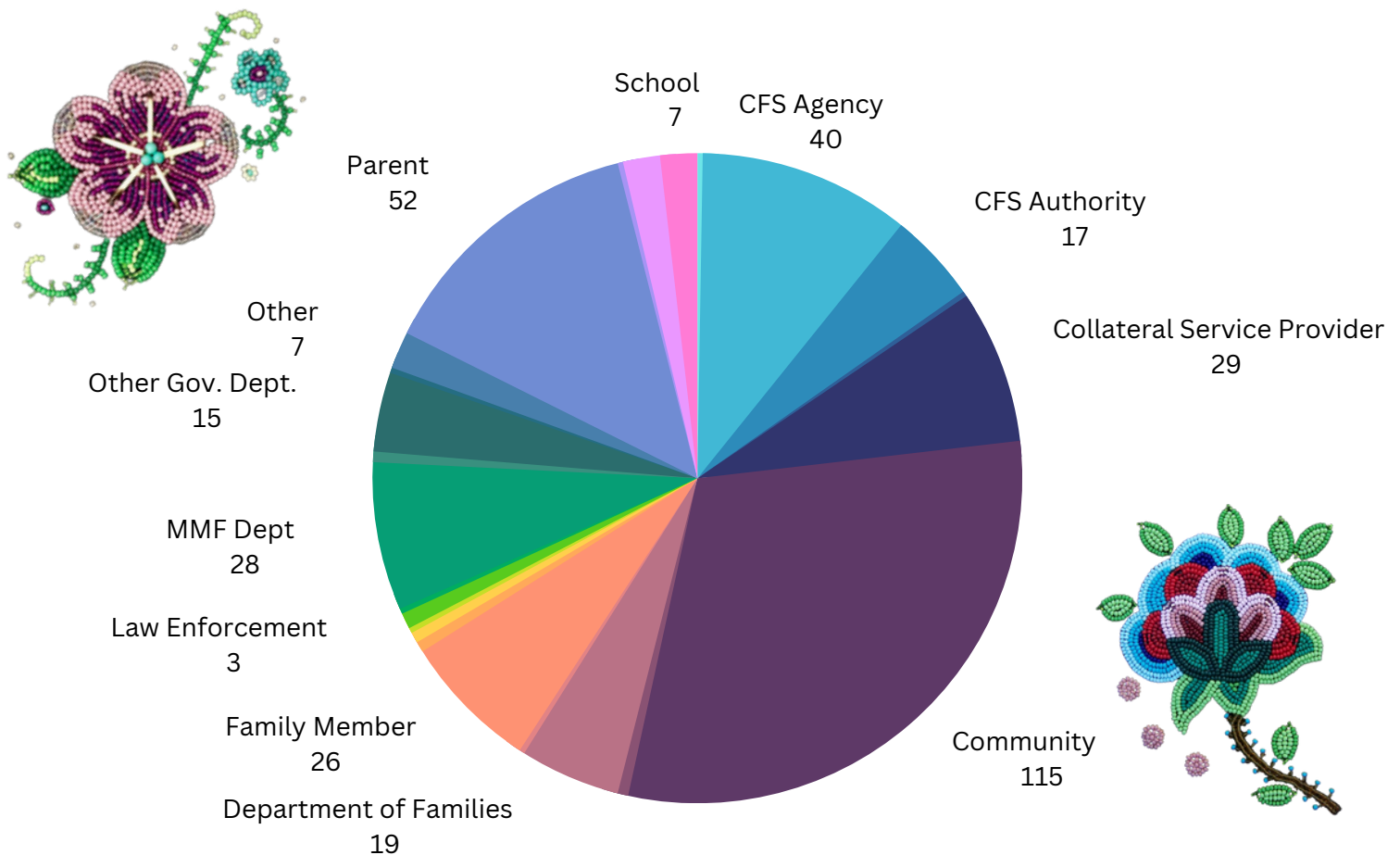

Funding is available under the SYA grant program until March 31, 2024 to support young adults transitioning out of the child welfare system. The SYA grant enables child and family services agencies to provide assistance to young adults who would normally not be eligible for an Agreement with Young Adults (AYA), either due to legal status or age. Young adults between the ages of 18-21 who are ineligible for an AYA due to legal status or young adults over the age of 21 (up to age 26) who have received continuous supports from their CFS agency are eligible to receive grant funding.

OUR AGENCIES

IMPLEMENTATION OF THE FEDERAL ACT (BILL-C92)

In 2020, the MMF was the first out the gate in requesting negotiations with Canada on the implementation of their new federal legislation, *An Act respecting First Nations, Inuit and Métis children, youth and families*. Initially, negotiations had significant delays from both levels of government, but we are proud to be moving forward quickly and in the best interest of our Red River Métis children and families. This means new Laws – ones that are designed for the Red River Métis by the Red River Métis and account for our history and way of doing things.

REGISTERED DISABILITY SAVINGS PLANS (RDSP)

Over the past four years, the agencies have been working towards having eligible children in care receive government funding owed to them through the Registered Disability Savings Plans (RDSP). Once deposited into these plans, the federal government matches these funds again through other grants and benefits resulting in the amount deposited being tripled. Each child in care with a disability would ultimately receive approximately \$12,000 per year (after grants) into their RDSP.

CHILDREN'S SPECIAL ALLOWANCE (CSA)

On May 18, 2022, the Manitoba judicial system ruled that the misappropriation of benefits for children in care was unconstitutional and discriminatory against Indigenous foster children. This was a long and hard-fought battle from our Métis CFS system along with other Indigenous child welfare agencies.

MÉTIS CART

The Métis Community Addiction Response Team (Métis CART) is an initiative that recognizes that intergenerational trauma affects parenting. Parents who have experienced trauma often struggle with substance misuse and mental wellbeing. This program is an early intervention service program for approximately 30 families at any given time with co-occurring parental substance misuse and/or mental health struggles with children at risk of coming into care. The program is comprised of a team including a caseworker, family mentor, addictions worker, and a mental health worker. The team also works closely with our Métis Connect team to ensure that family and community are welcomed to participate in network gatherings where they are able to talk about how they can support the family.

REGISTERED EDUCATION SAVINGS PLAN (RESP)

We are pleased to announce that all children in ongoing care have had Registered Education Savings Plans created for their future use. The importance of education in breaking the cycle of poverty, which affects so many families we are involved with, is vitally important.

Currently, these RESPs contain federal grant funding only. Our children in ongoing care have received about \$250,000 in Registered Education Savings Plan dollars thus far. Unlike the vast majority of other post-secondary level supports for children formerly in care, an RESP is in the control of the Youth themselves, and can be used at a broad range of educational institutions.

MÉTIS/MICHIF CONNECT

The goal of the Métis/Michif Connect Programs are to support staff with a shift in practice where MCFCS and Michif CFS staff consistently honor and welcome family and community as partners in support, planning and decision-making for their children. The Métis Connect Mentor coaches MCFCS workers in a "Family Seeing" approach of being with families that includes searching for, connecting with, and welcoming family. This program helps ensure that families have strong networks of support around them and that children in care have a sense of belonging through connection with family, identity, community, and culture.

Over this past year, the Métis Connect program has worked with almost 200 families involving over 300 children. They were also able to participate in over 300 network meetings for families and children and almost 1000 total network meetings since its inception!





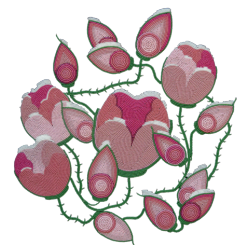
OUR AGENCIES

CONTINUED SUPPORT FOR YOUNG ADULTS

Our agencies continued to offer Agreements with Young Adults to all youth exiting care, even if they were not attending post-secondary education. The youth also continue to be supported by both the Métis Spirit and Skills for Life Programs which offer one-to-one and group supports to youth and young adults. These programs develop and improve life skills and practice problem solving skills when navigating various other necessary services.

BECOME A CAREGIVER

Our agencies are always looking for caregivers who can offer a loving and supportive home. No previous experience is required and we provide options between long-term and short-term care. Our agencies look to connect children-in-care with members of their immediate family, extended family, or members of the community. Please contact us today to help impact our Red River Métis communities, and help grow our children's future.



YOUTH CELEBRATIONS

Our agencies continue to host youth celebrations for our youth leaving care. Although these youth are entering adulthood, they are still able to access resources provided by our agencies through Agreements with Young Adults and other programs. These celebrations include food, music, jigging, speeches, and much more. Our Métis CFS System is so proud of all our youth, and we cherish these moments to shed a light on their amazing accomplishments and wish them well as they enter the next chapter of their lives.

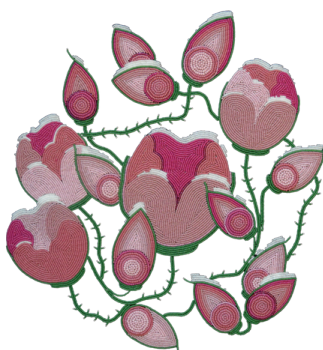
FINANCIAL REVIEW

Our audited financial results for the current and previous year indicate the usage of accumulated surplus and this is expected to continue in the coming year.

We continue to work with the other CFS Authorities on the calculation of amounts related to the transfer of children in care between the agencies across the system. Based on this, transfer of funds have been initiated and will continue as the transfers occur.

During the year, we worked in collaboration with MMF and put together a funding proposal which is being negotiated with Canada. The proposal covers the costs for the changes to be implemented in the Métis Child Welfare system as we transition to *Bill C-92: An Act respecting First Nations, Inuit and Métis children, youth and families*. The proposal includes the additional staffing, operations, IT infrastructure and capital requirements for system.

We appreciate the effort and support from MMF in negotiating the funding with Canada. Providing the relevant information and assistance to MMF in this regard continues to be our priority.
